**ARTICLE I**

The name of the corporation is EcoArts USA

**ARTICLE II**

The period of its duration is  Perpetual

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

OUR MISSION IS TO SUPPORT, COORDINATE AND LEAD ARTS, CULTURAL AND EDUCATIONAL EXCHANGE PROGRAMS BETWEEN ARTISTS OF COLOR FROM THE UNITED STATES AND ARTISTS IN LATIN AMERICA BY CULTIVATING, PROMOTING AND DOCUMENTING THEIR TALENT, CREATIVITY AND MAGIC TO TELL THEIR OWN STORIES AND HISTORIES.

**ARTICLE IV**

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

OUR VISION IS THAT OUR INTERNATIONAL ARTS AND CULTURAL EXCHANGE PROGRAM IS AN HONEST PERSON-TO PERSON ENGAGEMENT WHICH ENCOURAGES COMMUNICATION AND DIALOGUE TO PROMOTE BETTER UNDERSTANDING OF OTHER CULTURES AMONG PEOPLE FROM DIVERSE COUNTRIES, RACES AND ETHNICITIES AS THEY COME TOGETHER FOR A PROFOUND AND SUSTAINED ENGAGEMENT AMONG ARTISTS AND BETWEEN ARTISTS AND AUDIENCES.
