ARTICLES OF INCORPORATION

The undersigned acting as incorporator (s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

To manufacturer, design, style produce, process, prepare, merchandise, buy, sell, trasport, distribute, export, and import, at wholesale, retail, and as jobber, as principal, contractor, broker, representative, or agent or commission, and otherwise generally and in all ways handle, trade, and deal in and with any and all articles and items of mens', womens' and childrens' wearing apparel, clothing, garments, and undergarments, including, but not limited to, outerwear. shirts, sportswear, blouses, waists, pajamas, underwear, suits, coats, trousers, slacks, jackets, sport clothes, dress clothes, dress clothing, play clothes, work clothes, overalls, robes, swimwear, beachwear, leisure wear, playwear, cruise wear, sweaters, rainwear, undergarments, neckwear, scarves, nightwear, haberdashery, belts, wallets, furnishings, jewelry, footwaer, hats, caps, hoisery, athletic wear, camp wear, handkerchiefs, mufflers, knitwear, and any and all other articles of general wearing apparel, accessories, novelties, and specialties, of every kind, nature, and description, and for wahtever use and purpose and of every kind and type of material and composition.
