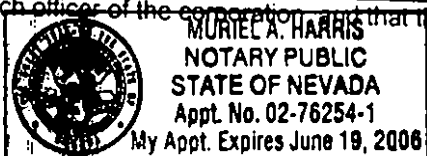

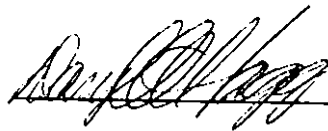

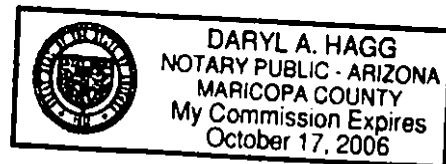

That for the purpose of forming a corporation under and by virtue of the laws of the state of Nevada, the undersigned incorporator does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is Greyhound Exposition Services, Inc.

ARTICLE II

The principal office of the corporation is to be located at One East First Street, in the county of Washoe, Reno, Nevada, but the corporation may maintain other offices at such other places inside or outside the state of Nevada as the Board of Directors may from time to time determine or as may be designated by the Bylaws of the corporation.

ARTICLE III

The nature of the business, or objects or purposes proposed to be transacted, promoted or carried on by the corporation are as follows:

(a) To engage in all forms of drayage, including moving, hauling and other types of transporting of merchandise, equipment and cargo by land, sea, air, rail or waterway.

(b) To decorate booths, halls, displays and exhibits for expositions, fairs, conventions or any other purpose whatsoever; to buy, manufacture, sell, import, export, design, trade and deal in and with banners, buntings, pennants, flags, badges, emblems, carpets, rugs, draperies, upholstery, booths, furniture, apparatus of any other material or product useful in creating displays or as decorations, and to rent or let the same for hire; and to carry on the business of display decorators, painters, printers, decorators, designers, or any other business necessary to carry out the objects of this corporation.

(c) To manufacture, purchase or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in, with goods, wares and merchandise, real and personal property, and services of every class, kind and description; except that is, not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company or association, cooperative association, fraternal benefit society, state fair or exposition.

(d) In general, to carry on any lawful business whatsoever, or in connection with the foregoing, or which is calculated directly or indirectly to promote the interests of the corporation or to enhance the value of its properties.
