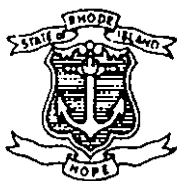

## BUSINESS CORPORATION

### ORIGINAL ARTICLES OF INCORPORATION

The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is WOOD FRAME STRUCTURES, INC.

(This is a close corporation pursuant to § 7-1.1-51 of the General Laws, 1956, as amended) (strike if inapplicable)

2. The period of its duration is (if perpetual, so state) perpetual

3. The specific purpose or purposes for which the corporation is organized are:

To engage in the business of constructing residential and commercial buildings; to manage the construction of residential and commercial buildings; to manage rental property; to obtain municipal approvals for zoning and subdivision of residential and commercial property; to buy, sell, and lease residential and commercial property; and to transact any lawful business for which corporations may be incorporated under the Rhode Island Business Corporation Act; and to have all the powers conferred upon corporations organized under the Rhode Island Business Corporation Act.

4. The aggregate number of shares which the corporation shall have authority to issue is:




