WHO WILL BE PARTICIPATING IN INTERSCHOLASTIC SPORTS; AND, (B) FOR STUDENTS CONTINUING THEIR EDUCATION FROM LASALLE ACADEMY WHO HAVE BEEN

ACCEPTED TO A COLLEGE OR UNIVERSITY IN PURSUIT OF A HIGHER EDUCATION.
