The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

First. The name of the corporation is PRINCETON INNOVATIONS, INC.

(A close corporation pursuant to §7-1.1-51 of the General Laws, 1956, as amended) (strike if inapplicable)

Second. The period of its duration is (if perpetual, so state) perpetual

THIRD. The purpose or purposes for which the corporation is organized are:

To invent, develop, and make improvements to products of all types and nature; to cause such products to be manufactured or licensed to parties to so manufacture such products; to create models and prototypes in connection therewith; and to perform any and all activities ancillary thereto, and each and every other lawful purpose (excepting banking and insurance).

FOURTH. The aggregate number of shares which the corporation shall have authority to issue is:

(a) If only one class: Total number of shares 800 shares common

(If the authorized shares are to consist of one class only, state the par value of such shares or a statement that all of such shares are to be without par value.)

(b) If more than one class: Total number of shares

(State (A) the number of shares of each class thereof that are to have a par value and the par value of each share of each such class, and/or (B) the number of such shares that are to be without par value, and (C) a statement of all or any of the designations and the powers, preferences and rights, including voting rights, and the qualifications, limitations or restrictions thereof, which are permitted by the provisions of title 7 of the General Laws in respect of any classes of stock of the corporation and the fixing of which by the articles of association is desired, and an express grant of such authority as it may then be desired to grant to the board of directors to fix by vote or votes any thereof that may be desired but which shall not be fixed by the articles.)

FIFTH. Provisions (if any) dealing with the preemptive right of shareholders pursuant to \$7-1.1-24 of the General Laws, 1956, as amended:

The corporation hereby specifically reserves the right to adopt applicable preemptive rights pertaining to its shares by means of stock purchase agreement(s) or cross purchase agreement(s), as may from time to time be executed, or as set forth from time to time in the bylaws of the corporation.



Sixth. Provisions (if any) for the regulation of the internal affairs of the corporation:

The corporation is organized as a close corporation pursuant to Rhode Island General Laws Section 7-1.1.51 (1956 edition, as amended); and the internal affairs of the corporation are governed by the bylaws and provisions of the statutes in such case made and provided.
