ORIGINAL ARTICLES OF INCORPORATION

The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

FIRST. The name of the corporation is Donna M. Hagerty, D.D.S., Inc.

(A close corporation pursuant to §7-1.1-51 of the General Laws, 1956, as amended) (strike if inapplicable)

SECOND. The period of its duration is (if perpetual, so state) perpetual

THIRD. The purpose or purposes for which the corporation is organized are:

Owning, operating and maintaining an establishment in which the practice of dentistry shall be carried on, pursuant to the Professional Service Corporation Statutes of the General Laws of the State of Rhode Island.

FOURTH. The aggregate number of shares which the corporation shall have authority to issue is:


