## **EXHIBIT "A"**

The corporation shall have the right to purchase its own common stock at the lowest price at which the holder thereof is willing to sell the same before the same shall be sold to any other party, and no sale or transfer of the common stock to the corporation to any other than the corporation shall be valid, nor shall any share of such stock be transferred on the books of the corporation to any other party other than the corporation unless said stock shall have first been offered in writing to the corporation by the holder of record thereof for sale at a designated price, nor such offer having been thereof made unless the corporation fails to accept said offer within thirty (30) days from the date of receipt thereof, or prior to the expiration of the thirty (30) days shall give notice in writing, to the holder of such stock that it does not desire to accept said offer, and no sale or transfer of such stock that it does not desire to accept said offer, and no sale or transfer of the stock of the corporation at a lower price than that at which the same shall have been offered in writing to the corporation shall be valid or give any person the right to transfer of the same on the books of the corporation.

Nothing herein contained shall prevent the transfer of the shares of the corporation stock by will or intestacy, provided, however, that such transfer shall be bounds by the terms hereof.

## **EXHIBIT "B"**

May elect a Board of Directors of not less than two (2) and no more than nine (9) members to conduct the business of the corporation, and any director may be removed without cause by the stockholders.

The officers of the corporation to be elected as the By-Laws may provide. The corporation may be dissolved as the By-Laws may provide, directors and officers may execute a Waiver of Notice for any regular or special meetings. The By-Laws of the corporation may be amended by a majority of the shareholders only.
