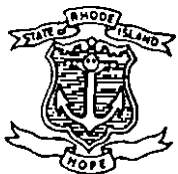

ARTICLES OF INCORPORATION  
(To Be Filed In Duplicate Original)

The undersigned acting as incorporator(s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

1. The name of the corporation is Ocean State Mooring and Marine, LTD.

(This is a close corporation pursuant to § 7-1.1-51 of the General Laws, 1956, as amended.) (Strike if inapplicable.)

2. The period of its duration is (if perpetual, so state) Perpetual

3. The specific purpose or purposes for which the corporation is organized are:

1. To remove, replace, install, anchor, maintain and otherwise deal in marine moorings.

2. To engage in any lawful business under the laws and statutes of state of Rhode Island.

4. The aggregate number of shares which the corporation shall have authority to issue is:
