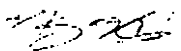
Limited Power of Attorney

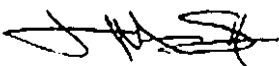

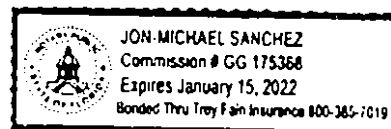
