I, the undersigned individual of the age of twenty-one years or more, do hereby adopt the following Certificate of Incorporation for such Corporation pursuant to the New Jersey Business Corporation Act.

1. The name of the Corporation shall be FEDERAL RENT-A-FENCE, INC.

2. The Corporation shall be for the purpose of any activity within the purposes for which Corporations may be organized under the New Jersey Business Corporation Act.

3. The aggregate number of shares which the Corporation shall have authority to issue is two thousand five hundred, each without par value.

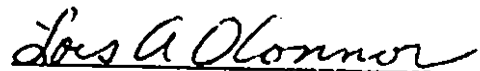

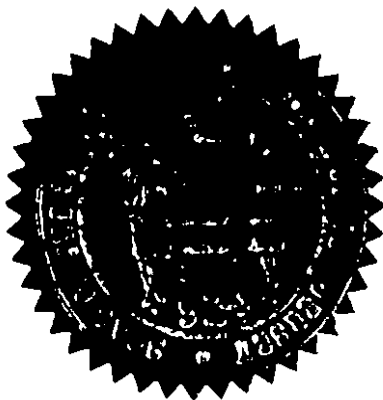
