**ARTICLE I**

TO SPREAD AWARENESS OF DOMESTIC VIOLENCE AND HUMAN TRAFFICKING.  
EDUCATING THEM TO IDENTIFY, SUPPORT, AND PROVIDE INFORMATION TO THOSE  
EXPERIENCING ABUSE. OUR FOCUS WILL BE WITH COMMUNITY STAKEHOLDERS,
