  continue until a Certificate of Dissolution has been issued by the Secretary of
  State of the State of Rhode Island.

The Corporation shall proceed to collect its assets, sell or otherwise dispose of such of its properties as are not to be distributed in kind to its Shareholders, pay, satisfy, and discharge its liabilities and obligations, and do all other acts required to liquidate its business and affairs.

5. After paying or adequately providing for the payment of all of its obligations, the Corporation shall distribute the remainder of its assets, either in cash or in kind, among its Shareholders according to their respective rights and interests.
