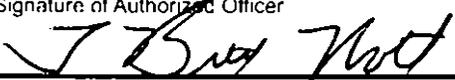

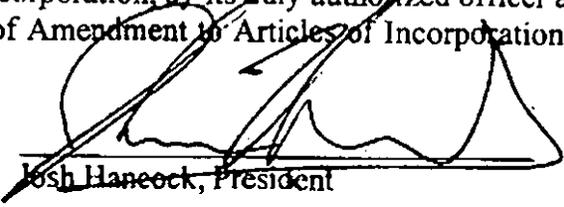
1. The name of the Corporation is Logistics & Technology Services, Inc.
