That ExxonMobil Oil Corporation was the Sole Stockholder of Mobil Chemical Company Inc., at the time of dissolution on January 20, 2010.

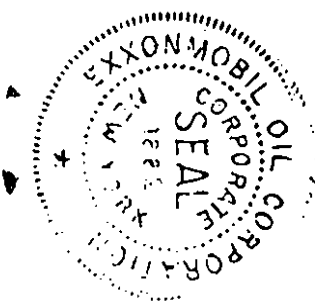
That the following is a true and accurate copy of a resolution adopted by the Board of Directors of ExxonMobil Oil Corporation on June 26, 2019:

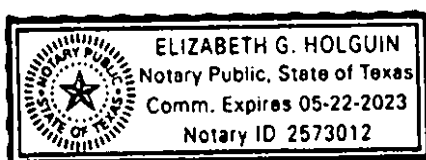

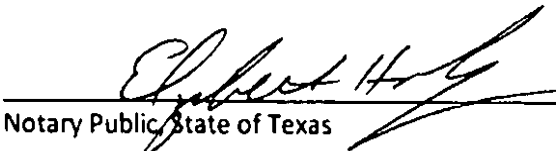
