**Non-Profit Corporation
Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Animal Rescue of New England

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

TO RESCUE ANIMALS FROM SITUATIONS THAT ARE ABUSIVE, ENDANGERING OR NEGLECTFUL.
TO RESCUE ANIMALS IN DANGER OF BEING EUTHANIZED AT SHELTERS/POUNDS.
TO PROVIDE FOSTER HOMES FOR THESE ANIMALS.
TO PLACE RESCUED ANIMALS INTO FOREVER HOMES.
TO EDUCATE AND PROMOTE THE IMPORTANCE OF SPAYING/NEUTERING COMPANION ANIMALS.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

NO OFFICER, AGENT, DIRECTOR, OR BOARD MEMBER SHALL HAVE ANY POWER OR AUTHORITY TO ENTER INTO ANY CONTRACT, RENDER IT LIABLE FOR ANY DEBTS OR OBLIGATIONS, EXECUTE, OR DELIVER ANY INSTRUMENT IN THE NAME OF, OR ON BEHALF OF THE ORGANIZATION. THE BOARD MAY HOWEVER, AUTHORIZE ANY DIRECTOR OR DIRECTORS, AGENT OR AGENTS, TO TAKE SUCH ACTIONS. SUCH AUTHORITY MAY BE GENERAL, OR CONFINED TO SPECIFIC INSTANCES. IN THE ABSENCE OF A CONTRARY BOARD AUTHORIZATION, CONTRACTS AND INSTRUMENTS MAY ONLY BE EXECUTED BY THE PRESIDENT, VICE PRESIDENT, TREASURE AND SECRETARY SERVING AS THE EXECUTIVE COMMITTEE.
