Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is HORSES FOR HOPE

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

HORSES FOR HOPE WILL BE ORGANIZED TO BENEFIT INNER CITY YOUTHS,
CHILDREN AND ADULTS FROM ALL RI AND VETERANS BY EXPOSING THEM TO THE
THERPAEUTIC BENEIFTS OF BOTH RIDING AND CARING FOR HORSES.
HORSES FOR HOPE IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, RELIGIOUS
AND EDUCATIONAL PURPOSES INCLUDING FOR SUCH PURPOSES THE MAKING OF
DISTRIBUTIONS TO ORGINIZATIONS THAT QUALIFY UNDER SECTION 501(C)(3) OF
THE INTERNAL REVENUE CODE AND ANY FUTURE CORRESPONDING SECTIONS. NO
PART OF NET EARNINGS OF HORSES FOR HOPE
SHALL INURE TO THE BENEFIT OF OR BE DISTRIBUTABLE TO ITS MEMBERS
TRUSTEES OR OFFICERSOR ANY PRIVATE PERSONS EXCEPT THAT THE
CORPORATION
SHALL BE EMPOWERED AND
AUTHORIZED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND
TO
MAKE PAYMENTS AND DISTRIBUTIONS TO THE FURTHERANCE OF THE PURPOSES
SET
FORTH IN THE PURPOSE CLAUSE HEREOF. NOTWITHSTANDING ANY OTHER
PROVISIONS OF THIS DOCUMENT THE CORPORATION SHALL NOT CARRY ON ANY
OTHER ACTIVITIES NOT PERMITTED UNDER TO BE CARRIED ON BY ANY
ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(C)(3) OF
THE IRS CODE, CORRESPONDING FUTURE SECTIONS OF ANY FEDERAL TAX CODE OR

BY AN ORGANIZATIONS CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNCEER
SECTION
170(C)(2) OF THE IRS CODE OR CORRESPONDING SECTION OF ANY FUTURE
FEDSRAL TAX CODE.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

UPON TERMINATION OR DISSOLUTION OF HORSES FOR HOPE ANY ASSETS

LAWFULLY

AVAILABLE FOR DISSOLUTION SHALL BE DISTRIBUTED TO ONE OR MORE

QUALIFYING

501(C)(3) ORGINIZATIONS . THE ORGANIZATIONS TO RECEIVE THE ASSETS SHALL BE DECIDED UPON BY A MAJORITY OF ITS MEMBERS OR MANAGING BODY. IF A MAJORITY CAN NOT BE

REACHED THEN UPON A VERIFIED PETITION OF EQUITY FILED IN A COURT OF LEGAL JURISDICTION AGAINST HORSES FOR HOPE BROUGHT ABOUT BY ONE OR MORE

OF ITS MANAGING BODY, THE COURT SHALL DECIDE WHICH 501(C)(3) ORGANIZATION SHALL GET ASSETS. IF NONE CAN BE LEGALLY FOUND BY THE COURT THEN THE COURT SHALL LAWFULLY AWARD SAID ASSETS OF HORSES FOR HOPE TO THE TREASURER OF THE STATE OF RHODE ISLAND TO BE ADDED TO THE GENERAL FUND
