Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is Green Politics Network

**ARTICLE II**

The period of its duration is  Perpetual

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

THE GREEN POLITICS NETWORK IS A NON-PROFIT, NON-PARTISAN VOLUNTARY ASSOCIATION ESTABLISHED TO CREATE, NURTURE, AND/OR EXPAND VARIOUS PROJECTS WHICH PROTECT AND RESTORE THE NATURAL ENVIRONMENT, PROMOTE SOCIAL JUSTICE AND EQUALITY, ENHANCE DEMOCRACY, AND ENSURE PEACE. ITS PROJECTS ARE BASED PRIMARILY IN THE UNITED STATES, BUT OTHERS WITH AN INTERNATIONAL FOCUS ARE ALSO ENCOMPASSED BY THE MISSION OF THE NETWORK. THE NETWORK ANTICIPATES OPERATING AS A TAX-EXEMPT ORGANIZATION UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, IN PURSUIT OF CHARITABLE, SPIRITUAL, EDUCATIONAL, SCIENTIFIC, LITERARY, AND FRATERNAL GOALS AS ALLOWED UNDER PROVISIONS OF SECTION 501(C)(3).

**ARTICLE IV**

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE INTERNAL AFFAIRS OF THE CORPORATION SHALL BE GOVERNED BY THE INITIAL BOARD OF DIRECTORS, AND THEREAFTER BY ADDITIONAL DIRECTORS, MANAGERS, AND OTHER AGENTS, AS SHALL FROM TIME TO TIME BE ELECTED OR APPOINTED TO THEIR ROLES BY MAJORITY VOTE OF THE THEN EXTANT BOARD OF DIRECTORS OR ITS ASSIGNEES, IN ACCORDANCE WITH THE CORPORATE BYLAWS, CONSISTENT WITH APPLICABLE LAWS AND

REGULATIONS OF THE STATE OF RHODE ISLAND AND THE UNITED STATES.
