IMPLEMENT PROGRAMS AT THE COMMUNITY AND INSTITUTIONAL LEVEL SEEKING
TO
INVOLVE JUVENILES, ADULTS, THEIR FAMILIES, WITHIN RHODE ISLAND, TO
COLLABORATE TOWARD RESOLVING CONFLICTS AND BUILD TRANSFORMATIVE
AND
RESTORATIVE JUSTICE IN ACCORD WITH THE TENETS OF ALTERNATIVES TO
VIOLENCE PROJECT

THE NONPROFIT SHALL DRAW UP ARTICLES OF DISSOLUTION IN COMPLIANCE WITH
TITLE 7 OF RHODE ISLAND GENERAL LAWS, AS AMENDED.
