The Corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code, as amended from time to time (the "Code") and regulations promulgated thereunder.

No substantial part of the activities of the Corporation shall be the carrying on or propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Code), or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

EXHIBIT B

FOURTH: Parent Support Network of Rhode Island, Inc. (the "Corporation") is not organized for profit and no part of the net earnings of the Corporation shall inure to the benefit of any member, director or officer (except that reasonable compensation may be paid to members, directors and officers for services rendered to and for the Corporation). In the event of the liquidation of the Corporation, whether voluntary or involuntary, no member, director or officer shall be entitled to any distribution or division of the Corporation's property or the proceeds thereof and upon such liquidation, the balance of all money, assets and other property of the Corporation, after the payment of all its debts and obligations, shall be used by or distributed pursuant to a resolution of the Corporation or an order of a court of competent jurisdiction, a nonprofit Corporation exempt from federal income taxation under Section 501(c)(3) of the Internal Revenue Code, or the Regulations thereunder or said assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or to the federal, state or local government, and which will use such property to accomplish the purposes for which this Corporation is constituted.

No director shall be personally liable to the Corporation or to its members for monetary damages for breach of the director's duty as a director; provided, however, that the foregoing shall not eliminate or limit the liability of a director (i) for any breach of the director's duty of loyalty to the Corporation or to its members; (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law; or (iii) for any transaction from which the director derived an improper personal benefit.
