Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is Roaring Lions Ministries

**ARTICLE II**

The period of its duration is  Perpetual

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

TO BRING AND TO ESTABLISH APOSTOLIC REFORMATION TO THE NATIONS TO PREPARE THE BRIDE FOR THE COMING OF THE LORD JESUS, THE CHRIST. TO EXECUTE THE APOSTOLIC MANDATE AND ACHIEVE THE RELATED PURPOSE, ROARING LIONS MINISTRIES INITIATES THE ESTABLISHMENT OF 10 ROAR HOUSES ON THE CONTINENTS. OUT OF THE ROAR HOUSES, GOVERNMENTAL PRAYER WILL BE RELEASED. ALL MINISTRY ACTIVITIES AS MENTIONED BELOW WILL BE EXECUTED FROM THESE ROAR HOUSES.

1. PRAISE AND WORSHIP, INCLUDING A SCHOOL OF THE PROPHETIC ARTS (SINGING, DANCING, PAINTING, ETC...)

2. PROPHETIC INTERCESSION ACCORDING TO THE ALTAR OF INCENSE. (EX.30; LEV.16; HEBREWS 7:25; 9:24; PSALM 141:2; JOHN 4:24; REV.5:8, REV.8:3, LUKE 18:1; 1 THESS.5:17) ROAR CALLS INTERCESSION IS A VITAL

PILLAR IN ROARING LIONS MINISTRIES. ON A WEEKLY BASIS ROARING LIONS MINISTRIES ORGANIZES A GLOBAL ROAR CALL BY VIRTUAL BROADCASTS. WE ALSO INVITE EXISTING 'STAND-ALONE' PRAYER GROUPS TO CONNECT WITH ROARING LIONS MINISTRIES AND BENEFIT FROM THE APOSTOLIC AUTHORITY AND ANOINTING.

3. EVANGELISM: PIONEERING ROARING LIONS MINISTRIES WILL CONTINUALLY PIONEER AND PLANT CHURCHES / HOMEGROUPS BY EVANGELIZING WHEREVER THEY ARE SENT TO. THIS WILL BE ACHIEVED THROUGH STREET CHURCH AND EVENTS.

4. DISCIPLESHIP: RLM WILL DISCIPLE THE SAINTS AND RAISE UP SPIRITUAL SONS AND DAUGHTERS TO CREATE APOSTOLIC ALIGNMENT OF EXISTING

CHURCHES AND/OR MINISTRIES. RLM DISCERNS ALIGNMENT PARTNERS, ASSOCIATE

PARTNERS AND FINANCIAL PARTNERS. EXISTING HOME-GROUPS, NOT BEING PART OF A CHURCH, ARE WELCOME TO CONNECT AND TRAIN WITH RLM AND ARE

WELCOME

TO BENEFIT FROM THE APOSTOLIC MANDATE.
