5. The reason(s) for filing the Articles of Dissolution are: Company name was established in error by an attorney whom we severed ties with in 2018. Business name was incorrect and we requested attorney to resolve the problem, which he never attended to. He also never forwarded us any correspondence so we were not aware of the status of this entity. The business name listed above has never been used in any form of business, and should be dissolved as soon as possible.	
6. State any other information or provision, not inconsistent with law, which the members or authorized person signing the Articles of Dissolution elect to set forth: We have contacted the RI Dept of Tax to ask for a waiver of annual business tax fees, and a Letter of Good Standing. Due to covid we are uncertain how long this will take, and meanwhile we wish to ensure that the business name is dissolved before end of 2020. Given the challenges with covid, and the fact that the business name was established in error originally by a third party whom we are no longer associated with, we humbly ask that the business name listed above be permitted to be dissolved with no further costs or delays.	
7. The limited liability company certifies that it has no outstanding tax obligations. As required by RIGL 7-16-8, the limited liability company has paid all fees and taxes. [Note: tax status can be verified at taxportal.ri.gov .]
