Articles of Incorporation

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Revolve Dance Project Inc.

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

TO FORM AN ORGANIZATION THAT WILL ENGAGE PERFORMING ARTISTS TO PRACTICE AND PERFORM DURING THE OFF-SEASON, AS WELL AS ORGANIZE LOW-COST PERFORMANCES FOR THE LOCAL COMMUNITY. THE PERFORMANCES WILL INCLUDE DANCERS, CHOREOGRAPHERS, MUSICIANS, AND OTHER VISUAL OR PERFORMING ARTISTS, ALL WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE.
