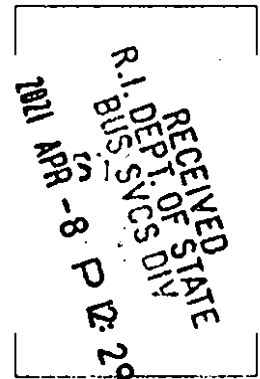

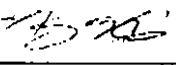
Limited Power of Attorney

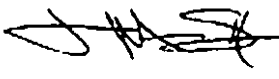

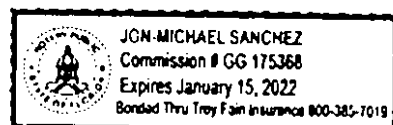
