ARTICLE I

The name of the corporation is Social Clarity Now

ARTICLE II

The period of its duration is  Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE PURPOSE OF SCN IS TO PROMOTE EDUCATIONAL MATERIAL REGARDING SOCIAL CLARITY AS A SYSTEMATIC APPROACH TO BETTER PARENTING, STRONGER RELATIONSHIPS, AND A SMARTER WORKFORCE. TO THIS END, THE PRIMARY OBJECTIVE OF SCN IS TO ADVANCE THE IMPLEMENTATION OF SUCH COURSES INTO EDUCATIONAL CURRICULUMS, SUCH AS, FOR EXAMPLE, CREATING A SCHOOL COURSE, POSSIBLY AS AN ELECTIVE, STARTING AN AFTER SCHOOL PROGRAM, MAKING A COLLEGE CLASS, OR BECOMING PART OF A CHARTER SCHOOL EXPERIMENT.
