2. Article V of said Certificate is amended to read as follows:

The partnership shall continue under the terms of the partnership articles as from time to time amended to and including December 31, 2000, unless sooner terminated by all the partners or by operation of law or unless the Executive Committee shall before said date give to the other remaining partners not more than six nor less than one month's notice in writing that the partnership shall terminate, specifying the date of termination, and in that event the partnership shall terminate on the date so specified.

3. Article VI of said Certificate is amended by striking out the first sentence and the list of contributions of limited partners and substituting therefor the following:

4. Article IX of said Certificate is amended to read as follows:

The compensation by way of income which each limited partner shall receive by reason of his contribution shall be:

- Each limited partner shall be entitled to receive on the last day of each month interest at a rate determined from time to time by the Executive Committee upon the amount of cash capital standing to his credit during the month.
- (b) Each limited partner shall be entitled to receive on the last day of each month such amount by way of a consulting fee as the Executive Committee shall from time to time determine.

(c) No limited partner is entitled to a percentage of the net profits of the partnership except J. Dudley Clark, Jr. and George C. Clark, 2nd, as determined from time to time by the "Clark Family Members" as defined in said limited partnership articles.

5. Article VIII of said Certificate is amended to road as follows:

No specific time is agreed upon when the contribution of any limited partner is to be returned except that upon termination of the partnership, the contribution of all limited partners, and upon the death or retirement of a limited partner, the contribution of such limited partner, shall in each case be returned on or within a determinable time subject with respect to the payment thereof to the Rules and Regulations of the New York Stock Exchange.

6. Article XI of said Certificate is amended to read as follows:

Additional limited partners may be admitted to the partnership by the Executive Committee.

7. Article XIII of said Certificate is amended to read as follows:

The partnership articles provide that neither the death, legal disability, withdrawal nor retirement of a partner shall terminate the partnership.
