Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Barrington United Veterans Coalition

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE MISSION OF THE BARRINGTON UNITED VETERANS COALITION (BUVC) SHALL BE TO ENHANCE THE WELL-BEING OF BARRINGTON'S VETERANS, THEIR FAMILIES, ITS MILITARY RESIDENTS, AND OUR COMMUNITY BY OUR DEVOTION TO MUTUAL HELPFULNESS. IN ADDITION, THE BUVC ADVOCATES FOR UPHOLDING AND DEFENDING THE UNITED STATES CONSTITUTION, AMERICAN VALUES, EQUAL JUSTICE AND OPPORTUNITY FOR EVERYONE AND DISCRIMINATION AGAINST NO ONE.
THE BUVC WILL FURTHER PROMOTE YOUTH EDUCATION, RESPONSIBLE CITIZENSHIP AND HONORING MILITARY SERVICE BY OBSERVING AND PARTICIPATING IN MEMORIAL EVENTS.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE PURPOSES FOR WHICH THE CORPORATION IS ORGANIZED ARE TO PROMOTE SOCIAL WELFARE WITHIN THE MEANING OF SECTION 501(C)(4) OF THE INTERNAL REVENUE CODE, INCLUDING BUT NOT LIMITED TO: (1) DEVELOPING AND ADVOCATING FOR LEGISLATION, REGULATIONS, AND GOVERNMENT PROGRAMS TO ENHANCE THE WELL-BEING OF BARRINGTON'S VETERANS, THEIR FAMILIES, MILITARY RESIDENTS, AND OUR COMMUNITY AT LARGE; (2) PROMOTING AND CONDUCTING EDUCATIONAL PROGRAMS AND COMMUNITY OUTREACH EVENTS THAT UPHOLD AND DEFEND THE UNITED STATES CONSTITUTION, SUPPORT AMERICAN VALUES, AND ENSURE EQUAL JUSTICE AND OPPORTUNITY FOR EVERYONE; AND (3) PUBLICIZING THE POSITIONS OF ELECTED OFFICIALS CONCERNING THESE ISSUES.

THIS CORPORATION IS NOT ORGANIZED FOR PROFIT, AND NO PART OF THE NET EARNINGS OF THIS CORPORATION SHALL INURE TO THE BENEFIT OF ANY MEMBER OF THE BOARD OF DIRECTORS OR ANY OTHER INDIVIDUAL EXCEPT THAT THIS CORPORATION MAY MAKE PAYMENTS OF REASONABLE COMPENSATION FOR SERVICES

RENDERED. THE CORPORATION SHALL NOT PARTICIPATE OR INTERVENE IN ANY POLITICAL CAMPAIGN ON BEHALF OF, OR IN OPPOSITION TO, ANY CANDIDATE FOR PUBLIC OFFICE TO AN EXTENT THAT WOULD DISQUALIFY IT FROM TAX EXEMPTION UNDER SECTION 501(C)(4) OF THE INTERNAL REVENUE CODE. THE CORPORATION SHALL NEVER BE OPERATED FOR THE

PRIMARY PURPOSE OF CARRYING ON A TRADE OR BUSINESS FOR PROFIT. NOTWITHSTANDING ANY PROVISION OF THESE ARTICLES OF INCORPORATION, THIS

CORPORATION SHALL NOT CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY AN ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(C)(4) OF THE INTERNAL REVENUE CODE OF 1986 (OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW).
