FIRST: The name of the corporation is Reynolds, Inc.

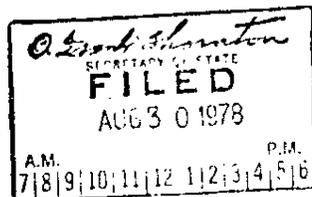
