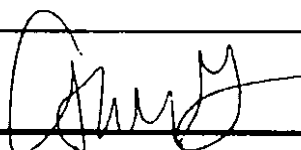

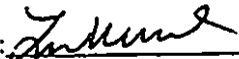
Limited Power of Attorney

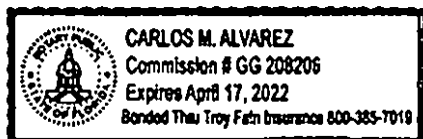
