- 3. That the Receiver's administrative claim in the amount of Ten Thousand Six Hundred Thirty Five Dollars and 20 cents (\$10,635.20) is allowed, and the Receiver is hereby authorized and directed to pay himself.
- 4. That the unpaid administrative expenses exceed the cash on hand, and the remaining funds of \$8,995.98 on hand shall be paid to the Receiver on account of the administrative claim allowed herein forthwith.
- 5. That the Receiver shall abandon the remaining assets identified in the Final Report to the auctioneer to dispose of them as he sees fit and to execute whatever documents necessary to effectuate the abandonment.
- 6. That said Receiver is hereby authorized to abandon all Defendant's books and records and any outstanding assets.
