1. That the Final Report of Giovanni La Terra Bellina, Temporary Receiver herein, and all acts, doings, and disbursements of said Receiver are hereby approved, confirmed and ratified.

2. That the Recommendation on Allowance of Claims filed herein by said Receiver is hereby approved.

3. That the Receiver's compromised administrative claim in the amount of Eleven Thousand Five Hundred and 00/100 Dollars (\$11,500.00) related to the Respondent is hereby allowed, the Receiver is hereby authorized and directed to pay himself on account of said allowed compromised administrative claim from the settlement proceeds held by Attorney Thomas Plunkett.

4. That the compromised administrative claim of Receiver's counsel Attorney Jay Katznelson in the amount of Eleven Thousand One Hundred Twenty-One and 70/100 Dollars (\$11,121.70) is hereby allowed and the Receiver is hereby authorized to pay Attorney Jay Katznelson from the settlement proceeds held by Attorney Thomas Plunkett.

5. That said Receiver is hereby authorized to abandon all Respondent's books and records and any outstanding assets.

6. That said Receiver is hereby discharged and the Receivership Bond ordered cancelled.

7. That Respondent corporation is hereby ordered dissolved and the Receiver is directed to forward a copy of this Order to the Office of the Secretary of State for the State of Rhode Island.

8. That this proceeding is now closed and may be reopened only upon the filing of a Motion.
