Articles of Incorporation

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Omena, Inc.

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

(A) TRAINING AND EDUCATIONAL SERVICES TO PROMOTE SOCIAL AND EMOTIONAL INTELLIGENCE, HEALTHY RELATIONSHIPS, AND BODY SAFETY IN SCHOOLS AND ELSEWHERE TO PREVENT AND BREAK THE CYCLE OF EMOTIONAL ABUSE; AND (B) ANY OR ALL OTHER LAWFUL BUSINESS FOR WHICH NONPROFIT CORPORATIONS MAY BE INCORPORATED UNDER THE RHODE ISLAND NONPROFIT CORPORATION ACT, R.I.G.L. § 7-6-1 ET. SEQ., AS CURRENTLY IN EFFECT AND AMENDED FROM TIME TO TIME HEREAFTER.
