Articles of Incorporation

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Prisoners Family Union

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

A UNIONIZED BODY OF FAMILY FRIENDS AND LOVED ONES THAT WANT TO TAKE AN ACTIVE ROLE IN THE LIVES OF THEIR LOVED ONES WHO ARE CURRENTLY AND FORMERLY INCARCERATED IN REHABILITATION. AS WELL AS TO ADVOCATE FOR CRIMINAL JUSTICE REFORM, PRISONER REHABILITATION, SOCIAL INJUSTICE, AND RACIAL DISPARITIES.
