Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Love Wins Little Compton

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

LOVE WINS LITTLE COMPTON UNDERSTANDS THAT THE WAYS THAT PEOPLE EXPERIENCE

THEIR SEXUAL AND GENDER IDENTITIES ARE INFORMED AND AFFECTED BY OTHER IDENTITIES, SUCH AS ETHNICITY, FAITH TRADITION, AND DISABILITY STATUS. GIVEN THAT UNDERSTANDING, WE AIM TO NURTURE A MORE WELCOMING, SAFE, INCLUSIVE, AND EQUITABLE ENVIRONMENT IN LITTLE COMPTON FOR PEOPLE OF ALL

SEXUAL AND GENDER IDENTITIES. WE WILL DO THIS BY:

FACILITATING EDUCATIONAL AND COMMUNITY-BUILDING PROGRAMS FOR RESIDENTS OF

ALL AGES AND IDENTITIES, IN COOPERATION WITH OTHER LOCAL GROUPS AND ORGANIZATIONS, WITH PARTICULAR ATTENTION TO THE NEEDS OF OUR LGBTQ+ RESIDENTS, THEIR LOVED ONES, AND THEIR ALLIES.

PARTNERING WITH OTHER ORGANIZATIONS, SUCH AS REGIONAL AND NATIONAL ORGANIZATIONS, TO EXPAND OUR RESOURCES, INCREASE OUR UNDERSTANDING OF

CURRENT LGBTQ+ ISSUES, AND BUILD ON OUR ABILITY TO ADVOCATE.

PROVIDING MUTUAL AID SUPPORT, AND PROFESSIONAL REFERRALS WHERE APPROPRIATE, FOR COMMUNITY MEMBERS EXPERIENCING CRISIS IN RELATION TO THEIR SEXUAL AND GENDER IDENTITIES.
