Articles of Amendment**

(Section 7-6-40 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Project Offset

WE ARE A PLATFORM THAT CONNECTS THOSE WHO CARE ABOUT REVERSING CLIMATE CHANGE WITH THE (OFTEN LARGELY UNKNOWN) ORGANIZATIONS THAT ARE ALREADY WORKING TO MAKE IT HAPPEN. WE ASSEMBLE A VARIETY OF EXISTING AND UPCOMING SUSTAINABILITY BASED PROJECTS FROM THESE ORGANIZATIONS, AND ALLOW BOTH INDIVIDUALS AND COMPANIES TO DONATE TO THESE PROJECTS. THIS ALLOWS THEM TO OFFSET THEIR CARBON FOOTPRINT AND ENABLE THE SUPPORTED PROJECTS AND ORGANIZATIONS TO DO MORE OF THE IMPORTANT WORK IN WHICH THEY ARE ENGAGED.

THE ORGANIZATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, EDUCATIONAL, AND SCIENTIFIC PURPOSES UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTIONS OF ANY FUTURE FEDERAL TAX CODE. UPON DISSOLUTION OF THE ORGANIZATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A

STATE OR LOCAL GOVERNMENT, FOR A PUBLIC PURPOSE.
