Articles of Incorporation

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Rhode Island Titans

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE RHODE ISLAND TITANS NON-PROFIT WILL ASSIST CHILDREN AND YOUNG ADULTS WITH NEUROLOGICAL DISABILITIES TO PARTICIPATE IN COMMUNITY RECREATION AND SPORTS BY RAISING FUNDS, FUNDING PROGRAMS, FUNDING EQUIPMENT AND ONE ON ONE ASSISTANCE THE ATHLETE MAY NEED TO PARTICIPATE.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

IF THE RHODE ISLAND TITANS ORGANIZATION DISSOLVES, ITS ASSETS MUST BE DISTRIBUTED TO LIFESPAN CHILDREN'S REHABILITATION SERVICES FOR THEIR USE TO FUND COMMUNITY RECREATION FOR DISABLED CHILDREN AND YOUNG ADULTS.
