Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is Lobby Muddy Fest

**ARTICLE II**

The period of its duration is  Perpetual

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

HOST EVENTS TO RAISE MONEY FOR CHARITY

**ARTICLE IV**

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

1. ANY ACTION REQUIRED TO BE TAKEN AT A MEETING OF BOARD OF DIRECTORS, OR ANY OTHER ACTION WHICH MAY BE TAKEN AT A MEETING OF BOARD OF DIRECTORS, MAY BE TAKEN WITHOUT A MEETING IF A CONSENT IN WRITING, SETTING FORTH THE ACTION SO TAKEN, SHALL BE SIGNED BY ALL BOARD OF DIRECTORS ENTITLED TO VOTE WITH RESPECT TO THE SUBJECT MATTER THEREOF.

2. ANY ACTION REQUIRED OR PERMITTED TO BE TAKEN BY VOTE OF THE BOARD OF DIRECTORS MAY BE TAKEN WITHOUT A MEETING ON THE WRITTEN CONSENT OF LESS THAN ALL OF THE BOARD OF DIRECTORS ENTITLED TO VOTE ON SUCH ACTION, IF THE BOARD OF DIRECTORS THAT CONSENT WOULD BE ENTITLED TO CAST AT LEAST THE MINIMUM NUMBER OF VOTES WHICH WOULD BE REQUIRED TO TAKE THE ACTION AT A MEETING AT WHICH ALL BOARD OF DIRECTORS ENTITLED TO VOTE ON SUCH ACTION ARE PRESENT.

3. NO DIRECTOR OR OFFICER SHALL HAVE PERSONAL LIABILITY TO THE

CORPORATION OR TO ANY OTHER DIRECTOR OR OFFICER FOR MONETARY DAMAGES FOR BREACH OF SUCH DIRECTOR'S OR OFFICER'S DUTY AS A DIRECTOR OR OFFICER, AS APPLICABLE, PROVIDED THAT THIS PROVISION SHALL NOT ELIMINATE OR LIMIT THE

LIABILITY OF SUCH PARTY: (I) FOR ANY BREACH OF SUCH PARTY'S DUTY OF LOYALTY TO THE CORPORATION OR TO THE OTHER BOARD OF DIRECTORS; (II) FOR ACTS OR OMISSIONS NOT IN GOOD FAITH OR WHICH INVOLVE INTENTIONAL MISCONDUCT OR A KNOWING VIOLATION OF LAW; OR (III) FOR ANY TRANSACTION FROM WHICH SUCH PARTY DERIVED AN IMPROPER PERSONAL BENEFIT.
