Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Women's Healing House

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

VISION: THE WHH'S VISION IS:

A COMMUNITY FREE FROM DOMESTIC VIOLENCE AND SEXUAL ASSAULT WHERE
MOTHERS
WITH THEIR CHILDREN CAN LIVE WITH HOPE IN SAFETY, RESTORATION, HEALING
AND
PEACE.

MISSION: THE WHH'S MISSION IS:

LEADING AND COLLABORATING WITH THE COMMUNITY TO PREVENT, PROTECT
AND
PREVAIL OVER DOMESTIC VIOLENCE AND SEXUAL ASSAULT THROUGH OUR FAITH
AND
ADVOCACY.

MOTTO: "YOU WILL BE HEALED"

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE BOARD OF DIRECTORS SHALL BE RESPONSIBLE FOR THE DEVELOPMENT,
MANAGEMENT
AND CONTROL OF THE AFFAIRS, PROPERTY AND FUNDS OF THE CORPORATION TO
ASSURE
THE EFFECTIVENESS OF THE WOMEN'S HEALING HOUSE. THE BOARD SHALL HAVE
THE

POWER TO GOVERN THE AFFAIRS AND PROPERTY OF THE WOMEN'S HEALING HOUSE, IN KEEPING ITS POLICIES IT ESTABLISHES THAT DEFINE THE BOARD'S SCOPE AUTHORITY AND LIMITATIONS. ALL "VOTING PRIVILEGES" ARE RESERVED FOR THE OFFICERS ON THE BOARD. THE BOARD OF DIRECTORS SHALL HAVE FULL POWER AND AUTHORITY TO ACT ON BEHALF OF THE ORGANIZATION AS MAY BE NECESSARY.
