(Chapter 7-1.2- of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is MLF Enterprises Corp.

LIABILITY OF SUCH PARTY: (I) FOR ANY BREACH OF SUCH PARTY'S DUTY OF LOYALTY TO THE CORPORATION ; (II) FOR ACTS OR OMISSIONS NOT IN GOOD FAITH OR WHICH INVOLVE INTENTIONAL MISCONDUCT OR A KNOWING VIOLATION OF LAW; OR (III) FOR ANY TRANSACTION FROM WHICH SUCH PARTY DERIVED AN IMPROPER PERSONAL BENEFIT.
