Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Make Noise Music Fund

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

TO SUPPLY LOCAL YOUTHS OF AQUIDNECK ISLAND THE OPPORTUNITY TO PURSUE PLAYING MUSIC. THIS FUND WOULD SUPPLY MONEY TO THOSE WHO WISH TO PLAY AND LEARN MUSICAL INSTRUMENTS TO COVER COSTS OF LESSONS, INSTRUMENT RENTALS AND EXTRAS NEEDED FOR INSTRUMENTAL PLAY. ALSO, MUSICAL INSTRUMENTS ARE DONATED AND FUNDS WILL BE USED TO REFURBISH THESE INSTRUMENTS WHICH WILL THEN BE DONATED TO THOSE IN NEED.
