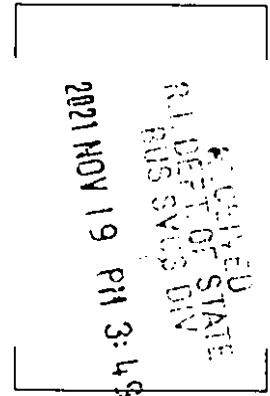

ASSET PURCHASE AND SALE AGREEMENT

- d) Seller's tradenames, including but not limited to "Rhode Island Uniform and Supply, Inc." which may be used by Buyer on and after the Closing; and

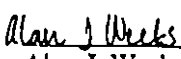
