Articles of Incorporation**

(Chapter 7-1.2- of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is Revell-Pechar, Inc.

This is a close corporation pursuant to § 7-1.2-1701 of the General Laws, 1956, as amended. (Uncheck if inapplicable.)

**ARTICLE II**

The corporation has the purpose of engaging in any lawful business, and shall have perpetual existence until dissolved or terminated in accordance with Chapter 7-1.2.

**ARTICLE V**

Additional provisions, if any, not inconsistent with Chapter 7-1.2 which the incorporators elect to have set forth in these Articles of Incorporation:

5(A). THE SALE OR TRANSFER OF STOCK HELD BY ANY STOCKHOLDER SHALL BE SUBJECT TO THE FOLLOWING PROVISIONS:

A SHAREHOLDER DESIRING TO DISPOSE OF, OR TRANSFER HIS STOCK AS AFORESAID, SHALL FIRST OFFER SUCH STOCK FOR SALE TO THE CORPORATION AT THE LOWEST PRICE AT WHICH HE IS WILLING TO SELL THE SAME. IF FOR ANY REASON THE CORPORATION IS UNABLE TO, OR FAILS TO PURCHASE SUCH STOCK, SUCH STOCK SHALL BE OFFERED TO THE OTHER SHAREHOLDERS OF RECORD IN PROPORTION TO THE NUMBER OF SHARES THEY HOLD FOR A PERIOD OF THIRTY (30) DAYS AT A PRICE NO LOWER THAN THAT AT WHICH IT WAS FIRST OFFERED TO THE CORPORATION.

IF THE REMAINING SHAREHOLDERS SHALL ELECT NOT TO PURCHASE SAID STOCK, THE SHAREHOLDER SHALL BE AT THE LIBERTY TO SELL HIS STOCK TO ANY OTHER PARTY AT A PRICE NOT LESS THAN THE PRICE AT WHICH IT WAS FIRST OFFERED TO THE CORPORATION AND TO THE REMAINING SHAREHOLDERS. THIS SECTION SHALL NOT ALSO APPLY TO GIFTS, SALES OR TRANSFERS BY A STOCKHOLDER TO MEMBERS OF THEIR IMMEDIATE FAMILY.

5(B). THE SAID COMMON STOCK, WITHOUT PAR VALUE OF THIS CORPORATION MAY BE ISSUED FOR CASH, PERSONAL OR REAL PROPERTY, TANGIBLE OR INTANGIBLE PROPERTY OR OTHER CONSIDERATION AS MAY BE FIXED BY THE MAJORITY OF THE STOCKHOLDERS.
