Dear Ms. Vivona:

The Office of the Attorney General has received your request to waive or reduce Vivona Inc.'s late fee for a delay in submitting the 2016-2021 annual reports. The reason stated for your request is it was believed that the report requirements had been met for those years.

Pursuant to R.I. Gen. Laws § 7-1-23, the Attorney General may "compromise" any penalty and permit the payment of a "smaller sum" than what has been assessed. There is, however, no provision for complete waiver of fees.

After reviewing the information that you provided to this Office and having found no consumer complaints or lawsuits against this company, this letter is to inform you that the Attorney General authorizes a reduction from \$300 to **\$30**. This is contingent; however, on the entity submitting the 2016-2021 annual reports to the Secretary of State and paying the filing fees.

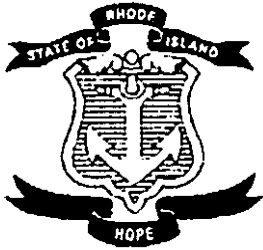

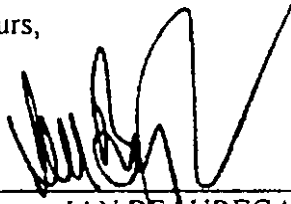
