1. They are the President and Secretary, respectively, of Teacher Created Materials, Inc., a California corporation.
2. The Articles of Incorporation of the Corporation shall be amended and restated to read in full as follows:

"I

The name of the Corporation is:  
Teacher Created Materials, Inc.

II

The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California, other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

III

This Corporation is authorized to issue only one class of shares of stock which shall be designated as common stock; the total number of shares which the Corporation is authorized to issue is 2,000. The shares of Common Stock may be issued from time to time in two series, designated, respectively, Common Stock, of which the Corporation is authorized to issue 1,000 shares, and Series B Non-Voting Common Stock, of which the Corporation is authorized to issue 1,000 shares. The rights, preferences, privileges and restrictions of the Common Stock and the Series B Non-Voting Common Stock shall be equal and identical in all respects, except that, unless otherwise provided by law, the holders of shares of Common Stock shall have and possess the exclusive right to notice of shareholders' meetings and shall have exclusive voting rights and power and the holders of the Series B Non-Voting Common Stock shall not be entitled to notice of any shareholders' meetings or to vote upon the election of directors or upon any other matters.

IV

The liability of the directors of the Corporation for monetary damages shall be eliminated to the fullest extent permissible under California law.

V

The Corporation is authorized to provide indemnification of agents (as defined in Section 317 of the California Corporations Code) through bylaw provisions, agreements with agents, vote of shareholders or disinterested directors or otherwise, in excess of the indemnification otherwise permitted by Section 317 of the California Corporations Code, subject only to the applicable limits set forth in Section 204 of the California Corporations Code with respect to actions for breach of duty to the Corporation and its shareholders."

3. The foregoing amendment and this Certificate have been duly approved by the Board of Directors of the Corporation.

4. The foregoing amendment has been duly approved by a majority of the shareholders of the Corporation in accordance with Section 902 of the Corporations Code. The total number of outstanding shares of this Corporation is 1,000. The number of shares voting in favor of the amendment exceeded the vote required. The percentage vote required was more than 50%.
