**ARTICLE I**

The name of the corporation is Congregacion Cristo La Vida

**ARTICLE II**

The period of its duration is  Perpetual

The specific purpose or purposes for which the corporation is organized are:

CONGREGACIÓN CRISTO LA VIDA PURPOSES AND ACTIVITIES WILL NOT BE ILLEGAL  
OR  
VIOLATE FUNDAMENTAL PUBLIC POLICY.
