Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Intruders Elite Academy Inc

ARTICLE II

The period of its duration is X Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THIS CORPORATION IS ORGANIZED AND OPERATED EXCLUSIVELY FOR ONE OR MORE OF THE FOLLOWING PURPOSES: CHARITABLE, EDUCATIONAL, SCIENTIFIC, AND RELIGIOUS PURPOSES. THIS INCLUDES THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE. THE SPECIFIC PURPOSE IS TO HAVE INTRUDERS ELITE ACADEMY UP AND RUNNING AS A HUB FOR STUDENT ATHLETES TO REACH THEIR HIGHEST POTENTIAL BEFORE HIGH SCHOOL. WE TARGET 7 THROUGH 8TH AND RECLASSIFIED 8TH GRADERS AND TEACH THEM HOW TO TAKE CARE OF THEIR BODIES PHYSICALLY AND MENTALITY.
