Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is National Empowerment Program for Women and Children USA

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

1. TO ENHANCE BASIC SERVICES IN REPRODUCTIVE HEALTH, COUNSELING, SEXUAL EXPLOITATION AND ABUSE THROUGH COMMUNITY SENSITIZATION CAMPAIGN.

2. TO ENHANCE THE AWARENESS OF BASIC HYGIENE, HIV/AIDS, CORONA VIRUS AND OTHER DISEASES PREVENTIONS FROM STAKEHOLDERS, PARENTS, YOUTH AND CHILDREN THROUGH EDUCATION AND COMMUNICATION.

3. TO ENGAGE IN LIVELIHOOD THROUGH ACTIVITIES FOR VULNERABLE PEOPLE THROUGH AGRICULTURE AND SKILLS TRAINING.

4. TO STRENGTHEN THE EDUCATION OF DOMESTIC VIOLENCE, GOOD GOVERNANCE, HUMAN RIGHT ABUSES AND CHILD PROTECTION.

5. TO EMPOWER THE COMMUNITY THROUGH COMMUNITY GROUP NETWORKS, EDUCATION AND PROMOTION OF BASIC HUMAN RIGHTS ACTIVITIES.

6. TO COLLABORATE WITH LOCAL AND INTERNATIONAL ORGANIZATIONS WITH SIMILAR OBJECTIVES.

7. TO PROMOTE CULTURAL HERITAGE.

8. TO CARRY OUT ALL LAWFUL ACTS THAT A CORPORATION IS AUTHORIZED TO TRANSACT UNDER THE BUSINESS LAWS OF RHODE ISLAND.
