Articles of Organization**

(Chapter 7-16-6 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The limited liability company has the purpose of engaging in any lawful business, unless a more limited purpose is set forth in Article VI of these Articles of Organization.

The period of its duration is: Perpetual

ARTICLE VI

Additional provisions, if any, not inconsistent with law, which members elect to have set forth in these Articles of Organization, including, but not limited to, any limitation of the purposes or any other

provision which may be included in an operating agreement:

6. ADDITIONAL PROVISIONS, IF ANY, NOT INCONSISTENT WITH LAW, WHICH THE MEMBERS ELECT TO HAVE SET FORTH IN THESE ARTICLES OF ORGANIZATION, INCLUDING, BUT NOT LIMITED TO, ANY LIMITATION OF THE PURPOSES OR DURATION FOR WHICH THE LIMITED LIABILITY COMPANY (THE "COMPANY") IS FORMED, AND ANY OTHER PROVISION WHICH MAY BE INCLUDED IN AN OPERATING AGREEMENT.

6.1 THE COMPANY'S PURPOSE IS TO INVEST IN QUALIFIED OPPORTUNITY ZONE PROPERTY AND TO HOLD SUCH PROPERTY TO ENGAGE, EITHER DIRECTLY OR INDIRECTLY THROUGH A SUBSIDIARY, IN ONE OR MORE QUALIFIED OPPORTUNITY ZONE BUSINESSES WITHIN A QUALIFIED OPPORTUNITY ZONE. THE TERMS "QUALIFIED OPPORTUNITY ZONE PROPERTY", "QUALIFIED OPPORTUNITY ZONE BUSINESS", AND "QUALIFIED OPPORTUNITY ZONE" HAVE THE MEANINGS PROVIDED BY SECTION 1400Z-2 OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED (THE "CODE"), THE TREASURY REGULATIONS PROMULGATED THEREUNDER, AND ANY ADMINISTRATIVE RULINGS OR OTHER GUIDANCE OF THE INTERNAL REVENUE SERVICE. THE COMPANY MAY ALSO ENGAGE IN ANY OTHER RELATED LAWFUL BUSINESS ACTIVITIES CONSISTENT WITH THE FOREGOING PURPOSE, AS MAY BE AUTHORIZED FROM TIME-TO-TIME BY THE MEMBERS.

6.2 THE COMPANY SHALL NOT MAKE ANY ELECTION OR TAKE ANY ACTION THAT WOULD CAUSE THE COMPANY, FOR PURPOSES OF THE INTERNAL REVENUE CODE OF 1986 (AS AMENDED), TO BE TREATED OTHER THAN AS A PARTNERSHIP OR A CORPORATION.

6.3 MEMBERS ARE NOT AGENTS OF THE COMPANY AND HAVE NO AUTHORITY TO BIND THE COMPANY UNLESS THEY ARE ALSO MANAGERS.

6.4 A MANAGER OF THE COMPANY, IF THERE BY ANY, OR A MEMBER ACTING IN THE CAPACITY OF A MANAGER (IN EITHER CASE, A "MANAGER"), SHALL NOT BE PERSONALLY LIABLE TO THE COMPANY OR TO ITS MEMBERS, FOR MONETARY DAMAGES

FOR BREACH OF ANY DUTY PROVIDED FOR IN SECTION 17 OF THE RHODE ISLAND LIMITED LIABILITY COMPANY ACT, AS AMENDED FROM TIME TO TIME (THE "ACT"), EXCEPT FOR LIABILITY OF A MANAGER FOR:

(1) BREACH OF THE MANAGER'S DUTY OF LOYALTY TO THE COMPANY OR ITS MEMBERS;

(2) ACTS OR OMISSIONS NOT IN GOOD FAITH OR WHICH INVOLVE INTENTIONAL MIDCONDUCT OR A KNOWING VIOLATION OF LAW;

(3) THE LIABILITY IMPOSED PURSUANT TO THE PROVISIONS OF SECTION 32 OF THE ACT RELATING TO WRONGFUL DISTRIBUTIONS; OR

(4) ANY TRANSACTION FROM WHICH THE MANAGER DERIVED AN IMPROPER PERSONAL BENEFIT UNLESS THE TRANSACTION WAS WITH THE INFORMED CONSENT OF THE MEMBERS OF A MAJORITY OF THE DISINTERESTED MANAGERS.

6.5 THE COMPANY SHALL INDEMNIFY AND ADVANCE EXPENSES TO ANY MEMBER, MANAGER, AGENT, OR EMPLOYEE, PAST OR PRESENT, OF THE COMPANY TO THE SAME EXTENT AS A CORPORATION FORMED UNDER CHAPTER 1.2 OF TITLE 7 OF THE RHODE ISLAND GENERAL LAWS (OR ANY FUTURE RHODE ISLAND FOR-PROFIT BUSINESS CORPORATION ACT) MAY INDEMNIFY ANY OF ITS DIRECTORS, OFFICERS, EMPLOYEES, OR AGENTS AND SUBJECT TO THE STANDARDS AND RESTRICTIONS, IF ANY, SET FORTH IN THE OPERATING AGREEMENT FROM TIME TO TIME.
