Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Global Fund to End Childhood Hunger and Poverty

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE PURPOSE OF THE CORPORATION IS TO INTENTIONALLY AND STRATEGICALLY
CREATE
PARTNERSHIPS, SECURE FUNDING, DELIVER GOODS, PROGRAMS AND SERVICES TO
POOR
AND VULNERABLE CHILDREN IN RHODE ISLAND, JAMAICA AS WELL AS OTHER
PARTS OF
THE WORLD.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE NON PROFIT ORGANIZATION, GLOBAL FUND TO END CHILDHOOD HUNGER
AND
POVERTY SHALL
NOT ENGAGE IN ACTIVITIES OR EXERCISE ANY POWERS THAT ARE NOT IN
FURTHERANCE
OF THE PURPOSES OF THIS ORGANIZATION OR THAT MAY ADVERSELY IMPACT THE
ORGANIZATION. THE BOARD OF DIRECTORS OF THIS ORGANIZATION SHALL ABIDE
BY
THE FOLLOWING OVERARCHING DUTIES:
1.DUTY OF CARE- CARING FOR THE INTEREST OF THE ORGANIZATION IN TERMS OF
ITS
MANAGEMENT AND PURSUIT OF CHARITABLE INTEREST.

2.DUTY OF LOYALTY- SERVING THE BEST INTEREST OF THE ORGANIZATION ABOVE AND PERSONAL INTEREST OF THEIR OWN.

3.DUTY OF OBEDIENCE- FOLLOWING THE RULES SET FORTH BY THE GOVERNING BODY AS WELL AS THE BYLAWS OR POLICIES OF THE ORGANIZATION, AS WELL AS THE EXTERNAL LAWS AND REGULATIONS THAT GOVERNS ORGANIZATIONS SO AS NOT TO JEOPARDIZE THE ORGANIZATION'S TAX EXEMPT STATUS.

4. ANY DIRECTOR OR OFFICER OF THE ORGANIZATION WHO ARE INVOLVED IN LITIGATION BY REASON OF HIS OR HER POSITION AS A DIRECTOR OF THIS ORGANIZATION SHALL BE INDEMNIFIED AND HELD HARMLESS BY THE ORGANIZATION TO THE FULLEST EXTENT AUTHORIZED BY LAW AS IT NOW EXISTS OR MAY SUBSEQUENTLY BE AMENDED (BUT, IN THE CASE OF ANY SUCH AMENDMENT, ONLY TO THE EXTENT THAT SUCH AMENDMENT PERMITS THE CORPORATION TO PROVIDE BROADER INDEMNIFICATION RIGHTS).
