Articles of Amendment**

(Section 7-6-40 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is Chabad on Campus-Kingston, RI, Inc.

C., OR THE CORRESPONDING SECTION OF ANY FUTURE TAX CODE; MORE PARTICULARLY AND ESPECIALLY, TO PROMOTE JUDAISM AND ITS TEACHINGS AND PRACTICES AMONGST PERSONS OF THE JEWISH FAITH, ACCORDING TO THE TEACHINGS OF CHABAD-LUBAVITCH AND THE REBBE, THROUGH RELIGIOUS OBSERVANCE AND COMMUNITY SERVICE. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THIS CORPORATION SHALL CONSIST OF CARRYING ON PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION AND THE CORPORATION SHALL NOT PARTICIPATE OR INTERVENE IN ANY POLITICAL CAMPAIGN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF STATEMENTS) ON BEHALF OF ANY CANDIDATE FOR PUBLIC OFFICE.
